# **Bowls Australia Policy: Affiliation and Eligibility to Play Policy**

#### 5 DUAL REGISTRATION – DECLARATION OF NOMINATED CLUB

- 5.1 All players in Australia <u>must</u> be registered with at least one (1) State or Territory Association (STA).
- 5.2 A player **may** be a member of more than one (1) affiliated Club.
- 5.3 A player **may** be a member of multiple Clubs in more than one (1) STA
- 5.4 A player must declare only one (1) of those Clubs in one (1) STA as their Nominated Club for the purpose of playing in State Championships and other championship events conducted by an STA or BA during a Bowling Season (all to be defined by the relevant STA).
- Playing in Pennant conducted by any STA shall not constitute a declaration of a player's Nominated Club under this policy. Players are permitted to play Pennant in more than one (1) STA without requiring a change to their Nominated Club. For clarity, Pennant is not a championship event.

#### **Bowls Queensland: Constitution**

#### 16 AFFILIATION FEES AND LEVIES

- 16.2(a) The Affiliation Fee shall be calculated on the basis of the number of ordinary members, life members (other than a Life Member of Bowls Queensland) and such other members entitled to play bowls at the Affiliated Club, as at the preceding 1<sup>st</sup> January.
- 16.2(b) All persons who are members of Affiliated Clubs shall be registered with Bowls Queensland on payment of the appropriate Club fee.
- 16.2(c) Club Affiliation fee in accordance with 16.2(a) will be paid in respect of a person having membership at more than one club, only once by the club member's registered (declared) club.
  - 16.3 Affiliation Fees relate to a calendar year and are calculated as at the 1<sup>st</sup> January each year and are due and payable in full by the March each year.

#### **Bowls Queensland: By-Laws**

#### 9. RIGHTS OF MEMBERS OF TWO OR MORE CLUBS OR DISTRICTS

- 9.1 No member shall play for more than one District in any competition conducted by Bowls Queensland in any one year without first obtaining the written permission of the Match Committee otherwise they may be disqualified and the District for which they were not qualified may also be disqualified from the competition.
- 9.2 For the purpose of this By-Law a member shall be deemed in each

- year to belong to the District for which they first played in the same year in any State competition
- 9.3 No member of a club, who has played in a competition arranged by any State Bowls Association or District Bowls Association or any country outside Australia shall, in the same year, play in any Association competition without first obtaining a clearance, otherwise they and the Club for which they played or either, may be disqualified from the competition.
- 9.4 No person who has played in an International Representative team or an Interstate Representative team, other than Queensland, shall in the same current year be eligible for selection in any Queensland Representative Team without first obtaining the written permission of the Board.

## Moreton Bay District Bowls Association: By-Law

#### **SECTION G**

#### MEMBERS OF TWO OR MORE CLUBS

The eligibility of members of two or more clubs to play in club championships and other club events shall be a matter for the clubs. District Clubs may include in their club constitution and conditions of play for club competitions, rules covering eligibility of members of two or more clubs to play in their events.

Any member of two (2) or more clubs shall "declare the club for which he wishes to be associated for playing of eligible events within the District no later than the 31<sup>st</sup> December each year, and such declaration shall apply for the ensuing district calendar year. No player may represent more than one (1) club in any one District year in inter-district competitions, District Championships or District Pennants.

Where a player transfers from another District, or another club, the player shall only be eligible to represent the District, or Club in inter-district competitions, District Championships and District Pennants if the player has not participated in any or all similar District events in the players previous District/Club in that year.

Any person, who has played in any Association match, or competition (excluding carnivals) arranged by an Association outside of this District shall not, in the same calendar year, play in any match, or competition (excluding carnivals)arranged by this Association.

No person who has played in any District representative team, other than for this District Association shall, in this District calendar year, be eligible for selection in any of this District's Representative Teams.

Any player, who contravenes any part of this bylaw, shall be disqualified from entry in any District events for the remainder of the District year, and/or may be fined, or suspended as a General Meeting, at its absolute discretion, may determine.

To be eligible to nominate, or be selected to play in a District team/side, a player must be a current financial member (not under suspension, or expulsion) at all their clubs.

# Kallangur Memorial Bowls Club: Rules of Association

#### 5. CLASSES OF MEMBERSHIP

(6) DUAL MEMBERS shall be any person who is affiliated with more than one Club, <u>but shall nominate one Club</u> as being the Club with which the player will be identified <u>for the purposes of playing Championship</u> <u>events</u> conducted by the District, State, Territory or National Authority. Members <u>NOT</u> declaring for Kallangur Memorial Bowls Club Inc, <u>will NOT</u> be eligible to compete in Championship Singles, Pairs, Fours.

## Kallangur Memorial Bowls Club: By-Laws

#### 12.2 Eligibility and Nominations

- (a) A player shall be a full financial member of the Club at the closing of nominations in order to be eligible to play in the respective championship and have paid the requisite entry fee for the event if applicable.
- (b) Members who are un-financial at the closing of nominations **WILL** not become eligible upon payment of fees.
- (c) All entries must be on the appropriate nomination form (accompanied by proof of payment if applicable) and placed in the entry box prior to the closing time and date. **LATE ENTRIES WILL NOT BE ACCEPTED.**
- (d) The player's name or Skip's signature must appear on the form signifying that you and your team have read the Conditions of Play and agree to abide by them.
- (e) Any member who is a member of more than one (1) Club <u>MUST</u> declare the Club they are playing for to BQ by the end of November. <u>Members nominating for Clubs other than</u> <u>Kallangur SHALL NOT BE ALLOWED TO COMPETE</u> in the Clubs <u>CHAMPIONSHIP SINGLES</u>, <u>PAIRS OR FOURS</u>. Dual members are still eligible to play in any other Club competition other than those listed above.
  - (f) Dual members whether they have declared for Kallangur or another Club shall be deemed to have played for Kallangur in Pennants after they have rolled their first bowl down in the pennant competition.

# QUEENSLAND INTRA CLUB PENNANT PERMIT REQUEST FORM

A player can be approved to play Pennant at another Club other than their Registered Club, as recorded with Bowls Queensland, by submitting this form to their District prior to the commencement of the Pennant competition in which they wish to play.

No application will be considered after commencement of a Pennant Competition unless agreed by the District.

This form must be endorsed by both Clubs for the Permit to be approved and a copy given to the District.

The approved Pennant Permit remains in place until the District Pennant season in that calendar year ends, and of which a player is not eligible to play Pennants for their Registered Club or another club in Queensland until the Pennant Permit expires.

A player may apply for a clearance on resignation from their Registered Club while a Pennant Permit is in place and the Pennant Permit automatically expires unless a player is transferred to another club in Queensland.
